In pursuance of this religious affiliation, we, the directors of Parakala Lakshmihayagriva Mission, USA make the following declarations:

1. We hereby agree to affiliate Parakala Lakshmihayagriva Mission, USA with Sri Brahmatantra Swatantra Parakala Matham of Mysore, India
2. We acknowledge that this affiliation is of an ecclesiastical nature based on acceptance, love and compassion
3. We acknowledge and accept the spiritual guidance of Sri Brahmatantra Swatantra Parakala Matham and its presiding spiritual pontiff, Sri Brahmatantra Swatantra Parakala Mahadeshikan (aka), Sri Parakala Swamy of Mysore, India as the supreme authority in doctrinal matters of Parakala Lakshmihayagriva Mission, USA
4. We acknowledge that in terms of legal jurisdiction our organization will remain an autonomous and independent whole
5. We acknowledge that our claim of affiliation with Sri Brahmatantra Swatantra Parakala Matham, Mysore India and the use of the name Parakala Lakshmihayagriva Mission, USA are conditioned on the basis of a continuing satisfactory relationship between our organization and Sri Brahmatantra Swatantra Parakala Matham, Mysore India and Sri Brahmatantra Swatantra Parakala Matham and its presiding spiritual pontiff, Sri Brahmatantra Swatantra Parakala Mahadeshikan (aka), Sri Parakala Swamy of Mysore, India may set conditions for withdrawal of authority to use the same and claim of affiliation
6. In pursuance of paragraph 5 above, we agree to have two honorary board members, who will serve as representatives of Sri Brahmatantra Swatantra Parakala Matham, attend the meetings of the Board of Directors of Parakala Lakshmihayagriva Mission, USA as non-voting participants
