2. REGISTERED OFFICE:

The Registered Office of the Trust shall be located in Bangalore, currently located at No 8, Parakala Mutt, Tank Bund Road , Bangalore – 560009 , or such other address(s) as may be decided by the Trustees from time to time.

3. JURISDICTION: BRAHMATANTRA SWATANTRA PARAKALA SWAMY MUTT SEVA TRUST can operate anywhere in India without any geographical limit of jurisdiction for its operations, but for all legal purposes, only the courts at Bangalore shall have jurisdiction.

- d. Managing Trustee means any person appointed and holding the said position in terms of the provisions of the Trust deed hereunder.
- e. Auditor means an Auditor appointed in terms of the Trust deed .

5. AIMS AND OBJECTS:

The aims and objects of the Trust are to support the following types of activities:

- a) Construction, repairs, maintenance, run and development of Religious Buildings, like, Mutts, Ashrams, and places of worship; Lecture halls, Library rooms, & Community Centres/halls, Goshalas (Cow sheds) Flower Gardens, Ponds, wells , Staff quarters, Accomodation like Rooms & Dormitories for Students, Visitors , Scholars, Devotees, Disciples, etc and similar areas associated with such buildings.
- b) Operation and maintenance of Religious institutions and places of worship ; celebrations of daily/periodic/special religious and other rituals, functions, festivals, other traditional events, conduct of scholarly meets/conferences/discourses, Teaching of Vedas, Divya Parbhadams, and other sacred scriptures and any other similar activities promoting spiritual upliftment of people.








- d) Helping financially or otherwise and assisting persons and institutions/organisations having objectives similar to this Trust
- e) And to do all such other acts and deeds, as may be deemed necessary, incidental, required and conducive for the attainment of the above aims and objectives, as may be desired/decided by the Trustees from time to time in consultation with the Founder Trustee.
- f) If any of the above objects is found to be inconsistent with the objects of a Public Religious and charitable institution under Sec 11 or any other section(s) of the Income Tax Act 1961 or any other direct tax law or any other law applicable to such trusts as now enacted or as may be enacted or amended in future , the objects stated above will be treated as so modified to be in accordance with such law or amended law so that the concessions , privileges, conditions or regulations available to and applicable to such public charitable institutions will be available or applicable to this Trust as well , so that this trust will continue to retain its character of a public charitable institution without profit motive but with public character within the meaning of such laws. All the objects of this Trust and the its activities will be confined to India and will be carried on without profit motive and without any distinction on account of caste, creed, colour, religion or sex.

6. MANAGING COMMITTEE:

- a) The affairs of the Trust shall be managed by a Managing Committee consisting of a maximum of Eleven and a minimum of Three Trustees, The members of the first Managing Committee are :

1. T.G. Ramesh
2. A.R. Badrinath
3. G.N. Kasturi Rangachar
4. N.R Keshava

The Managing Committee at its First meeting shall elect a Chairman and Managing Trustee, a Secretary and a Treasurer.

And the Trustees shall hold office for a term of three years at a time and are eligible for re-appointment and the office bears shall be appointed by the Managing Committee in consultation with the Founder Trustee.

- b) In the future, in the interest of the functioning of the trust, in an efficient manner, the Founder Trustee may replace , increase , or decrease the number of Trustees in the Managing within the limits prescribed above.
- c) In the event of a Managing Committee member's seat falling vacant, then the Founder Trustee may appoint a new Ton his place for any desired length of term.
- d) The Managing Committee shall meet at least once in Three months and at such other intervals as may be necessary and decided by Managing Trustee from time to time. The proceedings of the meeting shall be regulated by the Chairman of the meeting, who shall be the Managing Trustee.

- e) The quorum for the Managing Committee meeting shall be at least one third of the members of the Managing Committee, subject to a minimum of three.
- f) A Trustee shall vacate his position in the following cases:
 - i) End of the Trustee's stipulated term of Office
 - ii) Resignation of the Trustee and its acceptance by the Managing Committee.
 - iii) By removal of the Trustee by the Founder Trustee if he is found to have worked against the interest of the Trust and/or its aims and objectives, provided the Trustee proposed to be removed is given an opportunity to present his case, before such removal.
 - iv) If declared insolvent by an appropriate court of law or convicted by any court of law for moral turpitude or criminal offence.
 - v) Death .
- g) The Chairman shall preside over the Managing Committee and in his absence; the members present shall elect one among those attending that meeting to preside over that meeting.
- h) Every question which arises and/or decision taken at the meeting shall be decided by a majority of votes taken at the meeting (each member shall have one vote) and in case of equality of votes, the Chairman shall have a casting vote. There shall be no voting by proxy. A circular resolution signed by the Managing Trustee and a majority of the remaining members of the Managing Committee conveying their assent, shall be deemed to be a valid approval of the Managing Committee, subject to ratification at the immediate next Managing committee meeting.
- i) The Proceedings of the Meeting shall be recorded in the Minutes Book maintained for the purpose and signed by the Chairman of that meeting and ratified at the immediate next meeting.

- To open, operate and close Bank account(s) with any Scheduled Bank(s) including making and withdrawing investments, taking loans with or without interest and with or without security etc., with the approval of the Founder Trustee.
- To approve budgets, Audited accounts & the report of the Auditors thereon and Annual activity reports.

15. AMENDMENTS:




